RESPONSIBLE PURCHASING AND SUPPLY POLICY





At Industria Mecánica Vogt S.A. ("VOGT"), we recognize that our purchasing and procurement decisions are an essential part of the sustainability of the company and the mining value chain. Therefore, we promote procurement processes that integrate criteria of legality, ethics, environmental and social sustainability, favoring responsible and transparent relationships with our suppliers and strategic partners.

Applies to all purchases of goods, supplies, spare parts, materials, services, and third-party contracts necessary for VOGT's operations, both nationally and internationally.

It commits all areas and employees involved in purchasing and procurement processes. We also encourage our suppliers. contractors. subcontractors, and partners to share these principles. without this implying direct responsibility on the part of VOGT for their acts or omissions. VOGT may require adherence to this Policy in selection and contracting processes. without this implying the creation of contractual rights or obligations other than those expressly agreed upon.

In developing this policy, we drew inspiration from widely recognized frameworks and guidelines, such as:

- The United Nations Guiding Principles on Business and Human Rights.
- Sustainable Development Goals (SDGs), in particular SDG 8 (Decent Work), SDG 12 (Responsible Consumption and Production), and SDG 13 (Climate Action).
- Applicable national legislation, including labor, environmental, free competition, occupational health and safety regulations, and Law No. 20,920 (REP Law).

Our purchasing and procurement processes are based on the following principles:



LEGALITY

Comply with current regulations in all our acquisitions.



ETHICS, TRANSPARENCY, AND ANTI-CORRUPTION

Maintaining objective, clear processes free of conflicts of interest, in line with our Ethics, Transparency, and Compliance Framework.



SUSTAINABILITY

Consider the social and environmental impact of purchasing decisions in accordance with an approach proportional to risk and criticality.



SAFETY AND QUALITY

Prioritize suppliers who meet recognized standards (ISO 9001, 14001, 45001, or equivalent), considering the nature of the supply.



COLLABORATION

Establish long-term relationships based on trust and mutual respect



EFFICIENCY

Ensure efficient and responsible use of resources, balancing competitiveness with sustainability.

FUNDAMENTAL COMMITMENTS

In line with our principles, VOGT is committed to:

- Promote transparency and fair competition in its purchasing and contracting processes.
- Favoring, as far as possible, local and regional suppliers that demonstrate good environmental, social, labor, and corporate ethical practices, contributing to community and regional development. These practices must be in line with Law 21,595 on Economic Crimes and Law 20,393 on Criminal Liability of Legal Entities in Chile.
- Integrate sustainability considerations into supplier and contractor evaluations, in proportion to the nature of the purchases.
- Promote compliance with the REP Law and the circular economy through responsible management of materials, packaging, and waste associated with the purchasing process.

VOGT will progressively promote due diligence practices in its purchasing and sourcing processes, aimed at identifying, preventing, and mitigating social, environmental, labor, and human rights risks in the supply chain. The implementation of these practices will be developed gradually and adapted to the reality of the company, without generating direct contractual obligations.

VOGT has corporate mechanisms in place for receiving and managing complaints, which include accessible, confidential, and secure communication channels for suppliers, contractors, strategic partners, and collaborators to submit concerns, complaints, or claims related to this Policy or possible violations of ethical, environmental, labor, or human rights principles in the supply chain.

Any form of retaliation against those who, in good faith, file complaints or collaborate in their investigation is expressly prohibited. All cases will be handled in a timely and objective manner, respecting confidentiality.

VOGT's senior management leads the implementation of this policy, with the support of the various functional managers, and expects each employee to act in accordance with the principles set forth herein. This policy will be reviewed periodically to ensure that it is updated in accordance with regulatory changes, industry expectations, and in line with our other corporate policies.

This policy is for guidance purposes only and does not create any contractual rights or obligations. Compliance will be progressive and adapted to the operational reality of the company.
